Hamlets at Two Rivers
Outdoor Pool Rules and Regulations

Pool Admission

1. Access limited to Hamlets at Two Rivers Members and their guests.
2. Two Rivers Community Association (TRCA) requires each resident to have a current key FOB. Access. Key FOB's are not transferable and shall not be issued if there is a delinquency or deficiency in TRCA Dues. Key FOB access to the pool shall be revoked if a homeowner becomes delinquent in TRCA Dues.
3. Swim attire is to be appropriate for a community pool.
4. Any homeowner using the pools at times other than regular established pool hours will be banned from any further use of the pools for the remainder of the season and charged with trespassing.
5. Children under 11 years of age must be accompanied by an adult which is defined as a responsible person age 16 or older and directly supervises child.
6. Children 11-15 years of age must pass a swim test to come to the pool unsupervised.

Swim Tests

1. Standard swim test:
 - Must swim one long length of the pool
 - Tread water for one minute in deep end of the pool
2. Pool Management will supply wrist bands to members and guests that pass swim test.
3. Wrist band MUST be worn with every pool visit.
4. Swim test log is kept by the guards with test date, swimmer name and guard name.
5. Swimmers will have to re-take swim test if wrist band is forgotten/lost.
6. Swimmers who are found sharing their bands will be asked to exit water and guardian will be contacted.

Non-Swimmers

1. A non-swimmer is defined as anyone under the age of 16 who is not able to pass the swim test.
2. Non-swimmers may not come to the pool without adult supervision.
3. Non-swimmers who are not adequately supervised by a responsible adult will be asked to exit the water for the safety of the non-swimmer.
4. When using the pool, the guardian of the non-swimmer must be actively engaged in supervision and within arm's reach of their non-swimmer.

Pool Management

1. The lifeguard must be on duty and the pool officially open before swimmers are allowed in the water.
2. Only authorized personnel are permitted in the Pool Filter Equipment Rooms and on Guard Stands.
3. Emergency equipment and other lifeguard equipment are for use by Management Staff and lifeguards only.
4. If the pool becomes overly crowded no additional people will be admitted until space is available.
5. The lifeguard is responsible for strict enforcement of all rules/regulations. Guard has the authority to discipline/eject any homeowner or guest from the pool facilities for violations of rules or if their actions constitute a hazard to others.
6. The Pool Manager, Assistant Manager and lifeguards (Pool Management) may clear the pool at any time. At the signal to clear the pool, everyone shall exit the pool immediately and remain out of the pool until permission to return is given by Pool Management.

Discipline/Suspension

Pool Management shall have the absolute discretion and authority to suspend immediately the pool privileges of any member or guest for breaking the rules as posted or any of the following reasons, all of which shall be considered violations and subject to review by the TRCA Board of Directors (BOD). Additionally, a written incident report on all suspensions, containing the reasons, will be submitted to the TRCA Board of Directors for consideration.

- I. Nudity
- II. Lewd, obscene, indecent, improper or indecorous behavior and language
- III. Harassing lifeguards
- IV. Fighting
- V. Intoxication
- VI. Possession of illegal drugs
- VII. Possession of alcohol
- VIII. Vandalism

In addition to the immediate suspension, after review by the TRCA Board of Directors, the following suspensions may occur:

- 1st Warning – 30-day loss of use of facility
- 2nd Warning – 90-day loss of use of facility
- 3rd Warning – 12-month loss of use of facility

General

1. Smoking/vaping is prohibited inside/outside the pool areas, including grill areas, locker rooms, clubhouse.
2. Alcoholic beverages are prohibited in the pool areas.
3. Marijuana or any other illegal drug or substances is prohibited.
4. Persons under the influence of alcohol or drugs are prohibited from the pool and areas surrounding the pool.
5. No food or drinks are allowed within three (3) feet of the pool and must be kept within designated areas.
6. All trash must be disposed of in trash/recycle containers.
7. Pets (other than service animals) are prohibited on pool property.
8. Glass containers are prohibited.
9. Radios/iPod/Cell phones/Tablets and any other electronic device with sound shall be used with headphones.
10. Abrasive/profane language will not be tolerated. There will be a zero-tolerance policy regarding profane language, the use of which will result in immediate ejection from the pool by Management.
11. Pool guard may call a 15-minute rest period every hour on the hour at which time all patrons must exit the pool.
12. Cellular phone camera, camera, and video camera use is strictly prohibited in all locker, shower, and changing areas. Anyone found to be in violation of this policy will be prosecuted to the fullest extent of the law and banned from the facilities.
13. The pools may be closed at unscheduled times due to mechanical breakdown, operational difficulties, special events or other appropriate circumstances. The decision is at the sole discretion of Management and/or the TRCA Board of Directors.
14. Storage lockers are provided in the pool/fitness bathrooms. All items must be removed after use. No overnight storage permitted.
15. Infants/Toddlers must have appropriate swim diapers and swimsuit to enter the water.
16. The baby pool area is restricted to children under the age of 6 years old.

Safety

1. Diving into the pools is prohibited.
2. Running, pushing, towel snapping, wrestling, ball playing, or fighting in and around pool areas is strictly prohibited.
3. Playing, swinging, sliding, or sitting on ladders is prohibited.
4. Jumping from the lifeguard stands or chairs is prohibited.
5. Prolonged underwater swimming, breath-holding games or games including such behavior is prohibited.

6. The use of kickboards, inflatable mats (less than two feet in length), and water toys will be permitted at the discretion of the lifeguards.
9. Foam noodles are permitted.
8. Metal toys or objects are prohibited in the pool.
9. Only U.S. Coastguard approved floatation devices are permitted.

Health Safety

1. All persons shall shower before entering the pool.
2. Persons may not enter the water if they are experiencing or recovering from diarrhea or have had any signs or symptoms of a gastrointestinal (stomach) disease in the past seven days.
3. Persons suffering communicable illnesses, skin diseases, fungus infections, sore or inflamed eyes, excessive sunburn, open blisters/wounds, bandages, nasal or ear discharge, eye, ear, throat infections are prohibited from using the pool.
4. All injuries, however slight, must be reported to the Pool Management.
5. Spitting of water, blowing of noses, expectorating and similar unhygienic actions not be permitted in the pool area.

Pool Closing and Inclement weather

1. The pool/pool area may be closed at the discretion of Management in case of inclement weather which may include thunder, lightning, rain, threat of tornado/hurricane, operational breakdown or Anne Arundel County Health Department concerns.
2. At the sound of thunder, everyone must exit the pool water and move away from the waters edge. The pool will remain closed to swimming for 30 minutes after the last sound of thunder.
3. At the sight of lightning, everyone must exit the pool area, including the deck. The pool area will remain closed for thirty (30) minutes after the last sighting.

Liability

1. All persons using the pools or pool areas do so at their own risk. TRCA, Management or their agents do not assume responsibility for any accident or injury in connection with such use.
2. Members /Residents are responsible for any negative actions taken by their children, guests or themselves on Two Rivers Community Association Property. Actions resulting in rule violations, legal or monetary expenses must be addressed and fully compensated by the homeowner.
3. Any type of valuables brought to the pool facility shall be at the member's or guest's own risk. TRCA shall not be responsible for loss or damages to personal property.

Guest Policy

1. Each household shall be limit to no more than four (4) guests at one time.
2. Guests must be accompanied by a member 16 years of age or older with an active at all times.
4. Guest must exit pool area with the member.
5. Members are liable and responsible for guests, please see item #2 under the **LIABILITY SECTION**.
